Vehicles not displaying a current vehicle sticker by May 1st are subject to a \$100 ticket issued by the police department.

PLEASE READ THE FOLLOWING CAREFULLY

1. Return the entire form with the appropriate fee when purchasing a vehicle sticker. Make check payable to the "Village of Libertyville". Credit Cards accepted in person at the Village Hall.
2. All vehicle, truck and motorcycle licenses purchased after May 1st are increased by a \$20.00 late charge.
3. Vehicle stickers may be purchased at Village Hall beginning March 6.
4. To qualify for the Antique Vehicle rate you must have a registered Antique License Plate.
5. Village Hall Hours are 8 A.M. to 5 P.M. Monday through Friday

CIRCUIT BREAKER
Seniors and disabled individuals participating in the State of Illinois Circuit Breaker Program qualify for a \$5.00 license on one automobile per family.

*SENIOR CITIZEN / DISABLED RATES ARE AVAILABLE FOR RESIDENTS WHO ARE 65 OR OLDER WITH PROOF OF AGE OR RECEIVE SOCIAL SECURITY DISABILITY. **ONLY ONE SENIOR CITIZEN OR DISABLED RATE PER FAMILY IS ALLOWED** AND THE VEHICLE MUST BE OWNED AND OPERATED BY THE SENIOR FOR NON-COMMERCIAL USE. MAY NOT BE USED FOR MOTOR HOMES / TRUCKS.
