### Request is for new signage.

# HPC 22-15 Robert Bleck, Authorized Agent for Eleven5 Lake LLC. 137 Lake Street

#### Request is for new building facades.

Mr. Robert Bleck, authorized agent for Eleven5 Lake LLC, presented the proposed signage for 137 Lake Street. Mr. Bleck stated the scope of work includes enclosing the patio on the west side with a glass wall system. Mr. Bleck stated there are three panels that will drop into a static panel on the bottom. Mr. Bleck stated the bottom panel will be three-feet tall and a perfect screen from the vehicles. Mr. Bleck stated the petition includes having a portion of the wall on the interior side of the building, but it is understood that portion is not permitted by the Zoning Code. Mr. Smith confirmed that the interior portion of the wall will be removed from the scope of work. Commissioner Flader questioned the color of the frame for the glass. Mr. Bleck stated the color is black and it will match the standard system approved for Casa Bonita.

Commissioner Galo made a motion, seconded by Commissioner Rooney, to recommend the Village Board of Trustees approve the application for new building facades at 137 Lake Street, in accordance with the plans submitted.
